- As of December 1, 2020, full time CPRO employees now have group health insurance benefits
- Received 2<sup>nd</sup> FY2021 grant installment from Arlington County
- Submitted Initial FY2022 budget/grant request to Arlington County
- The Black Heritage Museum of Arlington is now being housed in the CPRO Space
- Two programs have recently been launched:
  - o Meals for ASPAN
  - o Restaurant Blanket Program
- First ever EOY Campaign has reached 70% of goal

# Committee Reports:

- **Executive** Met regarding food insecurity programming. Currently pursing 5 initiatives (4 have complete or partial funding)
- Finance Separate committee will be meeting regarding Luncheon and/or Birthday party in preparation for a Finance Committee meeting in February 2021.
